BOOKING CONFIRMATION

Upon receipt of this invoice and confirmation, payment for WTM Virtual 2020 must be received within thirty days. **Delegate places will be confirmed upon receipt of payment only.** By making payment all delegates are accepting the following terms and conditions.

PAYMENT

VAT will be added to all delegate rates at 20%. An invoice for the balance will be issued **circa 9 October 2020** and payment is due within 30 days. UKinbound reserves the right to deny exhibitor access to WTM Virtual should any costs related to this booking be outstanding at the commencement of the event.

GDPR

By making payment I agree that my data may be shared with other attendees and selected sponsors. I am aware this does not affect my existing privacy preferences with UKinbound.

MEMBERSHIP

Companies applying for a Member Rate **must be a fully paid member of UKinbound for the membership year 2020/21 at the time of WTM Virtual 2020.** If membership has lapsed, not been renewed, renewal payment not been received or if the company has not yet joined the association, UKinbound reserves the right to charge the difference between the cost stated above and the non-member rate

CANCELLATIONS

Cancellations must be notified in writing no later than **Friday 9 October 2020.** Cancellations received in writing on or prior to this date will be entitled to a refund, less the non-refundable deposit of £500+VAT. Cancellations received after this date will not be entitled to any refund and the full exhibiting costs will be charged.

FORCE MAJEURE

If WTM Virtual is unable to proceed due to virtue of a Force Majeure event, or the Force Majeure event has interfered with the organising and or delivery or holding of the show, this Contract and/or the Event (or any part thereof) may be terminated by the UKinbound or postponed.

UKinbound may retain such part of the fees paid by the Exhibitor as shall be required to recompense it for expenses incurred up to the time such contingency shall have occurred and there shall be no further liability on the part of either party. UKinbound shall not be liable for any costs, damages, or expenses of the Exhibitor because of such termination.

If WTM Virtual London 2020 is postponed and/or is relocated by Reed Travel Exhibitions (or any part thereof) as a result of Force Majeure, UKinbound shall be entitled to retain the fees which shall be applied to the Services for the postponed or relocated Event as though no postponement and/or relocation had occurred.
